

COVID-19 Return to the Land Application Form

This program is for Dehcho First Nations members/ family units. Please read the Guidelines for information.

HOW TO SUBMIT AN APPLICATION:

Because of Public Health Advisories due to COVID-19, all Dehcho organizations' are working hard to minimize contact with others, therefore, this application process is to be completed through your cellular phone or computer or whatever device you may have.

If you don't have internet or a computer, we are asking you to reach out to those that do through a phone call and ask for their help with the application process.

We can use technology (phones and computers) to still get things done.

- **Step 1:** Fill out the Application on your device.
- Step 2: Fill out the form completely and save it to your computer as COVID APPLICATION
- Step 3: Send the form to the email address provided on the guidelines document provided.
- **Step 4:** Wait to hear back.
- Step 5: Follow instructions from the caller in Step 4 above on how you are to get your supplies
- Step 6: Go on the land with your family, take pictures, submit these pictures back to your community office

Remember that this program is to provide assistance and NOT intended to cover all your costs of having your family out on the land during this COVID-19 pandemic. You may apply for assistance again after 14 days of being out on the land.

Enjoy your time out on that land with your family and stay safe and healthy.

General Safety Guidelines

Whether you are in town or in the bush, remember to follow the general guidelines:

- Regular handwashing or use hand sanitizer
- Avoid touching face (eyes, nose, ears and mouth)
- Coughing into your sleeve (or into a tissue and discarding)
- Practice physical distancing
- If you are sick, stay home in your community and contact your health center to tell them your symptoms and follow their recommendations.
- If you are on mandatory isolating for 14 days you cannot use this funding to go on the land.
- Please note that the NWT Public Health Official has advised people not to gather in large groups. If you are going on the land, you must still follow the guidelines of the NWT Public Health Official.

9. Waiver:

I agree that by receiving this funding I will not make any claim(s) or commence any legal proceeding(s) against Dehcho First Nations, and any of their member organizations and/or its officers, directors, employees, agents and officials for damage resulting from personal injury, illness, death and/or property loss, arising and sustained by me or my family members as I voluntarily, on my own free will, go out on the land during the COVID-19 pandemic. This includes any damage arising during transportation to and from my camp and any excursions we take in the area around our camp.
