Gladys Norwegian Grand Chief RE: Edehzhie

WHEREAS, Edéhzhíe is a spiritual place that is ecologically and physically unique. Its lands, waters and wildlife are integral to the Dehcho Dene culture, language and way of life;

WHEREAS, The Dehcho Dene are keepers of these lands, waters and wildlife given to them by the Creator, and are responsible for upholding Dene laws and the directions of their Elders to protect Edéhzhíe;

WHEREAS, Edéhzhie is a spiritual place that is ecologically and physically unique. Its lands, waters and wildlife are integral to the Dehcho Dene culture, language and way of life;

WHEREAS, The Dehcho Dene are keepers of these lands, waters and wildlife given to them by the Creator, and are responsible for upholding Dene laws and the directions of their Elders to protect Edéhzhíe;

WHEREAS, the Dehcho First Nations and Canada have worked together over many years to secure the permanent protection of the lands, water and wildlife of Edéhzhíe;

WHEREAS, The Dehcho First Nations intend to protect and manage Edéhzhíe in accordance with Dene Law, and have prepared a Dehcho Protected Area Law to give effect to this intention;

RE: Edehzhie

THEREFORE BE IT RESOLVED THAT THE ASSEMBLY:

- 1. approves and enacts the Dehcho Protected Area Law (2018);
- authorizes the DFN Grand Chief to enter into the Edéhzhíe Establishment Agreement with Canada of behalf of the Dehcho First Nations; and
- 3. authorizes the Dehcho First Nations to finalize the Establishment Agreement with Canada and to do such other things as may be necessary to permanently protect Edéhzhíe, and to work with the Chief and Council of the Liidli Kue First Nation (Fort Simpson), Tthets'éhk'é Déli First Nation (Jean Marie River), Deh Gah Got'ie First Nation (Fort Providence), Pehdzeh Ki First Nation (Wrigley), Fort Providence Metis Council, and Fort Simpson Metis Local to bring Edéhzhíe into operation.

Dehcho Protected Area Law (2018)

The Dehcho Assembly enacts the following law respecting the designation and management of Dehcho Protected Areas

PREAMBLE

- The Dehcho Dene have lived on and governed our lands and waters according to our laws and systems of governance since time immemorial;
- 2. The Dehcho Declaration (1993) affirms the inherent rights and powers of the Dehcho Dene to govern as a nation;
- 3. The Dehcho Dene are keepers of our lands and waters, and uphold the teachings of our Elders as guiding principles;
- 4. Dehcho lands and waters sustain our culture, language and way of life. These lands must be protected and maintained as a foundation to ensure that we thrive as a people into the future.

INTERPRETATION

5. Dehcho Protected Areas are areas of Dehcho land and waters set aside for permanent surface and subsurface protection from development.

MANAGEMENT

- 6. The management of Dehcho Protected Areas will:
 - a. uphold Dene laws that govern the relationship between Dehcho Dene and their lands and waters;
 - b. incorporate and strengthen Dehcho Dene Zhatié as the foundation for Dene Náodhee;
 - c. promote the transmission of Dene knowledge and Dene Náodhee from present to future generations.

PROHIBITIONS

7. No activities that would adversely impact the integrity of lands, waters or Dene Náodhee within a Dehcho Protected Area will be permitted.

DESIGNATION

- 8. Dehcho Protected Areas will be described and designated by the Dehcho Assembly and included on Schedule I.
- 9. Once designated, Dehcho Protected Areas will be zoned under the Dehcho Land Use Plan as a Protected Area Zone and recognized within the Dehcho Process.

PARTNERSHIPS

10. Dehcho Protected Areas may be managed in partnership with other governments in accordance with an establishment agreement.

COMING INTO FORCE

11. This law comes into force on resolution of the Dehcho Assembly.
