MANDATORY CRITERIA

PROPOSALS WILL REQUIRE A BUSINESS PLAN. THE INVESTMENT MANAGEMENT BOARD CAN ASSIST YOU WITH PUTTING A BUSINESS PLAN TOGETHER OR DIRECT YOU TO THE APPROPRIATE EXTERNAL RESOURCES

MEMBERS SEEKING FUNDING A SECOND TIME WILL REQUIRE EVIDENCE OF SUCCESSFUL COMPLETION OF PREVIOUSLY FUNDED PROJECTS

DEADLINES

MEMBERS AND ORGANIZATIONS WILL BE ABLE TO SUBMIT APPLICATION TO THE INVESTMENT MANAGEMENT BOARD UNTIL MARCH 31ST AND UNTIL SEPTEMBER 30TH, WHICH ARE THE DEADLINES FOR EACH YEAR
