Update to Main Table – December 11, 2012

Joachim Bonnetrouge (Chair)

- Status of Rolling Draft Committee awaits direction from Main Table on zoning options (provided to Main Table in early November) for two areas removed from original Edehzhie study area. Currently, these are zoned as Special Development. Committee will finalize rolling draft after direction is received from Parties regarding resolution of zoning of two areas
- Review of outstanding issues in Rolling Draft for Main Table Parties have provided positions and the Draft Memo is ready to go pending direction from Parties on the Rolling Draft to finalize document.
- 3. Financial Report –Six month variance and forecast to year end has been completed and has been reviewed by the Committee. Committee has provided direction to add in following 2 new work item – begin work to update 2005 Background Report maps, provide half day workshop at mid December DFN leadership meeting (see draft agenda at end of this report).
- 4. Inventory of Assets Committee staff have completed inventory of assets. Committee has approved write-off of outdated electronic equipment (older laptops, old photocopier) and directed staff to contact Dehcho communities to see if anyone wants this equipment on a first come, first serve basis. One request has been received. Equipment not wanted will be sent for recycling.
- 5. Workshop with Dehcho Community Resource Managers –. A second workshop is proposed for early 2013 in Fort Simpson when the winter roads are in for the 6 Dehcho organizations that could not make it to the October workshop. The workshop cost about \$14,000. There will be follow-up with the participants to review the workshop. The workshop format will be revised based on "lessons learned" from the first workshop.

DLUPC Update to Main Table – DRAFT December 7, 2012

- 6. Status of Committee the Committee met by conference call on November 22, 2012 AGM. Although GNWT and Canada members were not at meeting, quorum was recognized a DLUPC By-law 5(d) states "...A majority of members of the Society constitutes a quorum at all meetings....". The next conference call is scheduled for December 14, 2012. The federal Minister has not yet appointed a member to replace Bob Overvold. The GNWT member remains under instructions to not participate for the time being. The Committee will carry on with all Committee business except for completing the Rolling Draft and the Memo on Outstanding Issues. These two items will be completed once Canada and GNWT members attend meetings again.
- 7. Status of DLUPC Workplan see attached table. As noted previously, 2 new work activities have been added. Main activities that are behind schedule are:
 - a. completion of Rolling Draft and Memo on Outstanding Issues that are to be provided to the Parties to begin an internal review process that is expected to take about 6 months
 - b. Implementation Workshop
