Update to Main Table – December 9, 2014

- 1. Status of Rolling Draft and Draft Memo On Outstanding Issues in Rolling Draft DLUPC has not reviewed the Rolling Draft of the Interim Land Use Plan or the Draft Memo on Outstanding Issues in Rolling Draft since June 2012, the last time there was a federal appointee to the Committee. The Working Group has been proposing technical changes and last met November 17. The next Working Group meeting will be in January 2015. The Committee will review changes that Working Group has proposed since June 2012 on January 15, 2015. Canada will be asked to confirm who will be able to participate on that date.
- 2. Stakeholders Presentations -
 - Dehcho municipal governments Chair and Committee member Allen Bouvier completed updates to Dehcho municipal governments with a presentation to Hamlet of Enterprise on December 1. Mayor and Council appreciated the update and want to see land use plan completed.
 - 2014 NWT Geoscience Forum presentation was provided on November 25, 2014 by the Executive Director on the Dehcho Interim Land Use Plan's proposed Conformity Requirements, Actions and Recommendations relating to oil, gas and mineral land use activities in the Dehcho. This built on the presentation made at the 2013 Forum.
- 3. 2014 DLUPC scholarship as there were no applications over the summer, the Committee re-advertised the opportunity. Committee is confirming a recipient.
- 4. Lack of federal appointment it has been over 2.5 years since there was a federal member on the Committee. This continues to delay progress on completion of a plan and there were no Committee meetings between July and December 2014. The Committee will be writing to Minister Valcourt
- 5. Updating Dene Place Names Maps both Jean Marie River and West Point First Nations have responded to the Committee's June letter to update this map. Meetings were held on December 1 with West Point representatives and on

December 2 with Jean Marie River Chief and resource manager. DLUPC is partnering with DFN on this project. Draft interactive maps for each community should be completed by April 2015 to review at a spring Dehcho Dene leadership meeting.

- DLUPC Website rather than maintaining an independent contractor, the DLUPC will contact GNWT and DFN regarding hosting the website. GNWT currently hosts website for other collaborative initiatives, such as NWT Protected Areas Strategy and West Kitikmeot Slave Study.
