<b>C</b>		
<b>Capital Transfer</b> Taxation, Financial Payments	means an amount paid by Canada to Dehcho First Nations under the Financial Payments chapter.	
<b>D</b>		
<b>Dene</b> E &E,		-“Dene” used once as a standalone term, in provision 23.2.2 a) -Canada has identified an issue with this provision in a footnote. Suggest that the issue be resolved before defining term

<b>Enrolment</b>		-Enrolment is defined by provisions of

<b>Federal Public Service</b> Economic Measures		-used once in agreement, EM.2.1 b) iv) -Suggest de-capitalizing and removing from list of definitions
<b>Fish</b> Harvesting of Fish	means fish as defined in the <i>Fisheries Act</i> .	
<b>G</b>		
<b>Governor in Council</b> Interpretation		-Not typically defined in agreements. Suggest removing from list of definitions.
<b>I</b>		
<b>Implementation Committee</b> Implementation		-Term is defined by provisions of agreement -Suggest removing from list of definitions
<b>Implementation Plan</b> Implementation	means the plan developed by the Parties under the Implementation chapter to manage the implementation of the Dehcho

<b>N</b>		
<b>Navigable Waters (or just Waters)</b> Access		-Suggest separate definitions for Navigable and Water. Suggest removing “Navigable Waters” from list of definitions. Canada is still working on a definition for Navigable. Canada proposes a definition for Water below.
<b>P</b>		
<b>Preliminary Enrolment Period</b>	means the period of 18 months commenced by the Enrolment Committee under 4.3.1..	
<b>R</b>		
<b>Regulatory Authorities</b> Harvester Compensation		-Term used once in agreement, provision 20.2.4 -Canada has identified an issue with this provision in a footnote. Suggest that the issue be resolved before defining term
<b>W</b>		
<b>Water</b> Wildlife Harvesting, Migratory Bird Harvesting, Plant Harvesting, Harvesters Compensation, Dehcho Community Lands	means surface and subterranean water in liquid or frozen state located in or derived from a natural channel, a lake or other body of inland water.
